- Ralph has been approached re re-routing of dump trucks on Colonial. Linda stated this is a more complicated process and cannot be done on a street by street basis. Trucks also support local businesses. Marg will print this information in the *Nugget*. However Linda will put forward the suggestion that the City redesignate Colonial Road
- 5.8 Youth Dances - Tom Devecseri
- 310 youth at the last dance
 - profits around \$1518.00

- Budget discussions November 21 – public meeting
 - Flu clinics upcoming in Navan
 - Linda stated a citizen of Navan had written a letter to the mayor regarding updating the play structure in the park. Gord also suggested redoing the paths out to Wickham Street with stonedust to improve accessibility. Maybe this could be taken on by local groups such as NCA, Lions, Fairboard and WI.
 - Under City lifecycling programme the tennis courts are scheduled for resurfacing in 2009
- 5.10 City fees and storage shed – Suzanne Sanford
- Suzanne Sanford from the Recreation Department tabled a new schedule of fees for booking the Arena. It appears the Youth Dances should be paying a fee. Discussion took place around the costs and Suzanne will take our case to Council for being considered a programme and therefore eligible for the \$9.62 per hour rate.
 - Suzanne reported that the City would like to take down the storage shed at the end of the month. Anne-Marie will call Nancy Toonders to see if everything has been taken out. Suzanne will look into the cost of obtaining a container for storage, the cost of which can be borne by the NCA and Lions.

- A suggestion was made to come up with a master plan for the fairgrounds, including the playground area. Suzanne suggested applying for a Minor Capital Project Grant in which the City would match up to \$7,500.00 raised locally. If we wanted to be a little more ambitious we could go for a Major Capital Project Grant in the amount of \$50,000.00 under the same terms.
